The *Individuals with Disabilities Education Act (IDEA)* provides the foundation for inclusive schooling, requiring that every child with a disability receive a free and appropriate education and learn in the least restrictive environment. One approach to achieve the requirements of the law is to “retrofit”, meaning teachers solve problems after the fact in an attempt to fit a student into the existing framework. An alternative approach is “universal design”, meaning that the differentiated materials, methods, and assessment alternatives are considered and created in advance with the full range of students’ differences in mind. This course will show participants how to shift from retrofit to universal design for student diversity and curriculum access.

NOTE: This is a required course for Moderate Disabilities Professional Licensure Candidates

Three graduate credits are awarded for this course through Framingham State College, Framingham, MA.
